INSTRUCTIONS ON HOW TO COMPLETE THE AUTHORIZATION FORM

1. Language:

- Complete the information above in Hungarian language if you are a Hungarian citizen.
- If you are a foreigner, you can complete the form in either Hungarian or English.

2. Acceptable identity document:

- If you are a Hungarian citizen, you shall provide your Hungarian Personal ID Number (Személyi Azonosítószám). Exceptionally, if you do not have your Hungarian Personal ID Number, you could provide your Passport number.
- If you are a foreigner, you can provide your Passport Number or EU identification number listed in your EU ID Card, in this case it will be necessary to also tick the box corresponding to the type of document that you are providing and indicate its country of issuance.

3. Address:

- Full address of residence (from postal code to door number) is required.
- If you do not have an address in Hungary, please provide your full current address.

4. Signature:

- Wet signature is required.
- Your signature must match the signature in your identity document.
- The witnesses must sign on the same date as yourself.

5. Witnesses:

- On pages 2 and 3 you will find a section dedicated to witness signature, where two people should declare they have witnessed your signing of the Authorization.
- Witnesses should fill in the blanks with their own handwriting providing all the requested data.
- If the witnesses do not have a Hungarian personal ID number, it is enough to indicate their EU card or passport details, including country of issuance.
- Witnesses may use Hungarian language (preferable) or English.
- The signature of the Authorization Form and the signature of the witnesses must be on the same date.

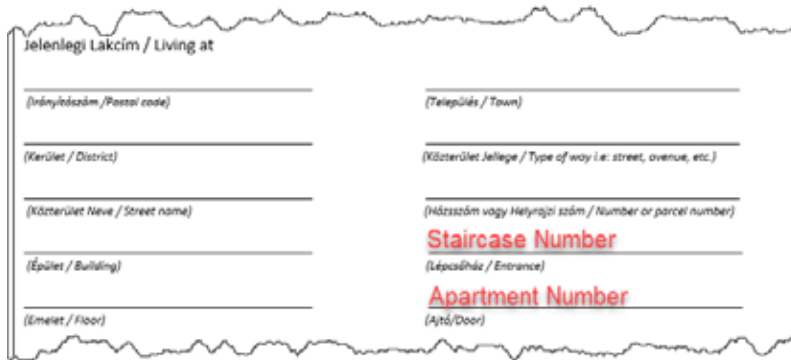
-  **Hungary Crim-Natl Form; must be signed by two witnesses.** All signatures must be wet ink signatures. Digital signatures will not be accepted.
-  Copy of General Notice / Consent for screening
-  Copy of ID (front and back required for double-sided IDs)
 - Citizens: Copy of National ID (Szemelyi Azonosito). Passport copy is not acceptable for citizens.
 - Foreigners: Copy of Foreign Passport or EU National ID Card

Instructions for Completing the Form

ALL INFORMATION ON THE FORM MUST BE COMPLETELY FILLED OUT.

The Form is in Hungarian and English. It must be completed in Hungarian if you are a Hungarian citizen. If you are not a Hungarian citizen, you may complete it in either Hungarian or English.

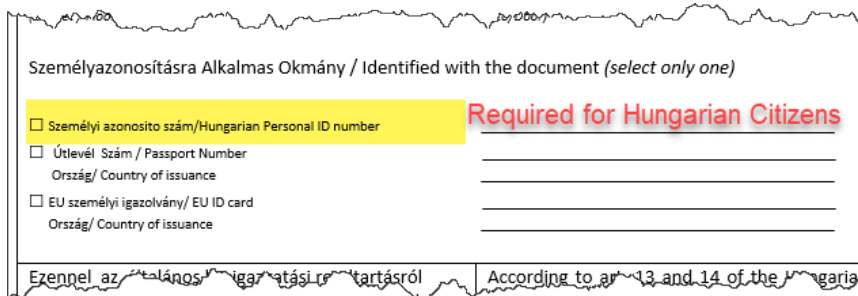
In the Address section, note the need for a staircase and apartment number, in addition to the street address. (If you do not have a Hungarian address, fill in as much as possible about your current address as matches the questions).

Requirements for Witness

The Form requires review and signature from two witnesses.

The witnesses can be family members, or they can be someone outside of the family.

The witnesses must be present when you sign the document. The witnesses must sign and date the form immediately after you sign the form.

The witnesses may complete either the Hungarian version or the English version. The Hungarian version is preferred.

The witnesses are required to provide their full name, date of birth, place of birth, address, and identification details. The ID should be either the Hungarian ID number, EU ID number, or passport number and issuing agency.
